1. I will be solely responsible for my Membership card. The Membership Card is non-transferable. No person other than the Member is permitted to use his/her Membership Card. Notwithstanding the foregoing, I will be liable for all charges incurred by any person who uses the Membership Card whether with or without permission, unless Durango Mountain Club receives written notice that the Membership Card is lost or stolen. I understand that Durango Mountain Club will have the right to revoke the Membership Card if it is used by someone other than the Pass Holder or otherwise misused.
2. I will notify the Durango Mountain Club immediately if:
 - a. My Membership Card covered by this agreement is lost or stolen.
 - b. My credit card expires; or
 - c. My credit card otherwise cannot accept the charge for the Membership Card Holder's purchases(s). (For example, my credit card is withdrawn or cancelled; the credit limit has been exceeded; my credit card is reported lost or stolen.)I will notify the Durango Mountain Club of any of these circumstances by calling (970) 247-9000, ext. 11220, and writing the Durango Mountain Club at 327 S Camino Del Rio, Durango, Colorado, 81303. Membership Card will be deactivated and will no longer be usable. Durango Mountain Club will be responsible for deactivating a Membership Card only if requested to do so in writing. Replacement Membership Cards are available for a processing fee of \$10 per card.
3. I will be personally liable for Membership Card charges if the charges are not accepted on my credit card for any reason.
4. I realize that the Membership Card is not a credit/charge card. I am only authorizing Durango Mountain Resort to charge my credit card for the items purchased using the members card at Durango Mountain Resort and the Durango Mountain Club.
5. I realize that if I have any questions concerning charges on my credit card from use of the Membership Card, I will call Durango Mountain Resort at the phone number listed in paragraph 2, or write Durango Mountain Resort at the address listed in paragraph 2. I also realize I will have the rights under my credit card provider agreement for billing errors and inquiries.
6. I have the right to terminate this credit card authorization at any time, but must do so in writing and, at the same time, must return to Durango Mountain Resort my Membership Card covered by this agreement.
7. I understand that the Durango Mountain Club may terminate this program or issue different Membership Cards at any time. I will return my Membership Card covered by this agreement to Durango Mountain Club upon request.
8. This agreement will be governed by the laws of the state of Colorado.
